Following a recommendation from the Board of Directors of the Lake County Solid Waste District to change disposal fees to cover increased costs of operation, the Board of Lake County Commissioners signed Resolution 21-32 (a) revising the Solid Waste Management District Disposal Fees

Effective February 1, 2022, disposal fees are as follows:

- **Wood Waste** Properly separated for disposal at the Class III Landfill o \$20.00 per ton
 - o Large Stumps and other difficult to handle materials are \$40.00 per ton
- **Construction and Demolition Debris** properly separated for disposal at the Class IV Landfill
 - o \$10.00 per cubic yard
 - o \$10.00 minimum charge
- **Concrete without rebar** and properly separated for disposal at Class III Landfill
 - o \$20.00 per ton
- **Large Animal** disposal at the Transfer Station
 - o \$80.00 per ton

- **PAY (Pay as You Throw)** - non-assessed waste, disposed of at the Transfer Station
 - o \$80.00 per ton
 - o \$10.00 minimum
- **Freon Appliances** - accepted at all site locations
 - o \$10 per unit for freon removal
- **Tires** – Accepted at all site locations – Must be smaller than 24.5 inches
 - o Passenger-Light Truck \$5.00 / with Rims \$10.00
 - o Semi Truck \$15.00 / with Rims \$20.00
- **Loads not properly separated** for disposal
 - o \$150.00 per ton at Transfer Station or Class III Landfill
 - o \$50.00 per yard at the Class IV Landfill
- **Special Handling of Other Large Waste Volumes**
 - o Fee set by mutual agreement between Lake County and Contractor, Waste Generator, or Waste Hauler

THE WASTES LISTED ABOVE MAY NOT BE DISPOSED OF AT THE LAKE COUNTY CONTAINER SITES.

Violations are actively pursued. Disposal fees are due upon disposal, unless billing arrangements are made prior to disposal.

LAKE COUNTY DOES NOT ACCEPT ASBESTOS IN ANY FORM.
