

## Transitional Living Center (TLC) Information for Applicants

1. SaVannah Carpentier, Intake/Eligibility Specialist at (406) 675-4491 ext. 1515, [scarpentier@skha.org](mailto:scarpentier@skha.org) will review your TLC application.
2. If application is complete and signed by all adults in your household, your application will be forwarded to Monique Gates, ext. 1516, [ggates@skha.org](mailto:ggates@skha.org) for final approval.
3. Savanah may ask for additional documentation before final approval of your application. Provide a good phone number with voicemail set up and a good mailing address.
4. Re-application for TLC is required if your application is over 6 months old.
5. When you receive a letter or a verbal word from Intake that your application has been approved, you will call TLC at (406) 675-3003 daily for unit.
6. Leave your name and contact number and **speak clearly**. "This is (name) calling in for a TLC unit. My phone number is (contact phone number)."
7. You must call in **consistently** to be considered for an available TLC unit.
8. The applicant that's been calling in regularly for the longest time period will be contacted first when a unit is available.
9. If you are contacted by the TLC Case Manager for an available unit, you must report for an eligibility drug test within 2 hours of the phone call. TLC staff may be able to give drug tests at other locations if you do not have transportation. Drug tests are observed.
10. Apply for SKHA rentals immediately. Apply for other income-based housing asap.
11. The lifetime maximum stay at TLC is 2 years. Previous time at TLC as head of household will be deducted from the 2 years.
12. Average waitlist time for SKHA rentals is 2+ years.
